INDEPENDENT AUDITOR'S REPORT ON REVIEW OF INTERIM FINANCIAL RESULTS

TO THE BOARD OF DIRECTORS OF M/S DYNAVISION LIMITED

1. We have reviewed the accompanying Statement of Standalone Unaudited Financial Results of DYNAVISION LIMITED ("the Company"), for the Quarter and Nine months period ended December 2018 ("the Statement"), being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as modified by Circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016.
